

INTRODUCTION



With the setting showed, **(Wheel removed to show the machine parts)** the machine acts as a regular two axes Cuttermaster.

Please read the CUTTERMASTER Operator's Manual for working directions on this type of setting.

The side sharpening of end mills is possible with this type of setting.



And also the sharpening of the front cutting edge of the end mills



By means of the raising handle



the wheel can be raised




to work with the discharge angle of the end mills



Releasing just one screw and the locking handle the wheel can be set at a desired angle.




to work inside the flutes of the end mills




Of course to set an special wheel for that type of work



the wheel guard should be removed and a proper one set instead







In addition, an extension should be set behind the wheel.









The new set up (with wheel) will look like:

And by means of the raising handle



the wheel height can be adjusted to work inside the flutes



Attention: to change the working angle, the wheel must be in the top position.
